**THIS MATTER** comes before the Court in connection with the upcoming Reverse Transfer Hearing-Proof Evident Hearing scheduled to begin on November 18, 2019. The Court observes that Chief Judge Orders CJO 14-21 (Amended Chief Judge Order Concerning Electronic Devices in Judicial Buildings) and CJO 19-04 (Chief Judge Order Regarding Certain Prohibited Activities at the Douglas County Justice Center)<sup>1</sup> remain in full force and effect and all parties, media, and all spectators are subject to the obligations set forth in those orders. In addition, this Court **ORDERS** as follows:

## COURTROOM DECORUM AND USE OF ELECTRONIC DEVICES

All parties and spectators must observe proper courtroom decorum. The following guidelines will be strictly enforced by the Court:

- 1. Audible comments and emotional displays and outbursts, as well as displays of insignias, symbols, pictures, clothing, or any other items that may influence the proceedings are *strictly prohibited*.
- 2. If, at any time during the proceedings, an individual feels the onset of an emotional reaction that may violate this Order, please quietly and discreetly exit the courtroom.
- 3. ALL CELL PHONES AND ELECTRONIC DEVICES MUST BE

## TURNED OFF OR ON SILENT MODE AT ALL TIMES.

- 4. No photography, audio or visual recording is permitted in the courtroom without prior approval of the Court.
- 5. Live reporting of any kind within the courtroom is *prohibited*.
- 6. Counsel involved in this case may have and use electronic devices to the extent necessary to access their calendars for scheduling purposes or other case specific needs (NOTE: Counsel shall not use their electronic devices for social media purposes).
- 7. Use of any such device in violation of this Order may result in temporary confiscation of the device and the initiation of contempt proceedings against the user, which could result in the imposition of a jail sentence, and the user may be barred from any further court proceedings in this case.
- 8. To the extent possible, the prosecutors and defense attorneys shall instruct the named victims, known family members, friends and supporters of the named victims and the defendant, concerning proper courtroom attire and behavior.
- 9. Counsel and their staff should observe spectators as they enter the courtroom to determine whether an issue needs to be raised with the Court outside the presence of the entire audience.
- 10. The Court will ask its staff to exercise the same vigilance.
- 11. No person is permitted to stand in the gallery of the courtroom (except Douglas County Sheriff's Office staff). Once the seating area of the gallery reaches capacity, all remaining individuals are required to proceed to the overflow courtroom to view the proceedings. Individuals who attempt to stand in the back of the courtroom will be escorted from the courtroom and directed to the overflow courtroom. The overflow courtroom is equipped with a television that will display the proceedings through a closed-circuit television system.
- 12. The rules outlined in this Order apply equally to the overflow courtroom, which is merely an extension of the courtroom where the hearing is taking place.
